Description of the Program:

API is a 66-bed inpatient acute psychiatric hospital with 3 outpatient programs, 3 Jackson House crisis houses and 1 Jackson House Residential Treatment Program.

The practicum trainee will be working exclusively in the inpatient hospital. They will be providing individual and group therapy across 3 units; units are based on acuity with 2 ICUs and 1 MHU or mental health unit. Population ranges from 18-90. Patients vary across all socio-economic-cultural demographics. Based on symptoms, trainees will conduct suicide risk assessments, danger to others assessments, behavior plans, domestic violence screenings, seclusion and restraint debriefs.

Required commitment is 12 months; if you complete your degree prior to the end of your commitment, you will be encouraged to apply for your intern number through the Board of Behavioral Sciences. You have a 90-day window in which you can count hours towards licensure while you await the intern number. This way you do not lose any hours towards your licensure.

Trainees are required to work 20 hours a week. This includes occasional weekend day of 8-hour shift. On that week, you will work 28 hours. You will "bank" those 8 hours worked to use as vacation or sick time in addition to your 6 days a year of vacation/sick time. The hospital is 24/7. Psychology and Addiction hours are Saturday through Thursday from 8-430 and Fridays from 7:00-3:30 pm. Friday is supervision day with one hour of didactic from 7-8 with the entire department. Small group supervision of 8 or fewer trainees will be from 8-10. Your one hour of individual or triadic supervision is determined by trainee's schedule.

No previous clinical experience is required. Requirements include professionalism, personal responsibility, and open mind and a sense of humor.

West Coast Recovery Center's mission is to provide an individualized program of recovery to inspire healthy life changes. Trainees will garner an understanding of the addictive process, recovery treatment and dual diagnoses which often accompany addiction (PTSD). Interns and trainees will acquire skills in dual diagnosis screening and assessment measures, treatment planning and mindfulness-based psychotherapy. Training will be provided on HiPAA, DAP progress notes, Ethics/Legal concerns, Dialectical Behavioral Therapy (DBT) Skills and Behavior Chain Analysis, and Mindfulness practice. My theoretical orientation is based in mindfulness and DBT, thus interns can count on exposure to these DBT skills, mindfulness practices and emphases on behavior.

Group supervision sessions always begin with 5-10 minutes of mindfulness, meditation, or Wise Mind practice. We then follow with case presentations, teach-ins and/or countertransference issues. Clinical staff are regularly exposed to training and fellow case presentation from somatic based, sensori-motor psychotherapy for PTSD, 12 step, SMART, holistic approaches, as well and EFT and systems understandings of addiction and treatment.
